Vader Keith Muller is leraar van St. Augustine Anglikaanse Kerk in Melkhoutfontein, waar hy sedert 2021 werksaam is.

Hy het teologie studeer aan St. Paul's College te Grahamstad en daarna diplomas en kwalifikasies in verskeie ander vakgebiede verwerf.

Sy spesiale belangstelling is die ontwikkeling van landelike gemeenskappe, armoedeverligting, opleiding van werkers, bestuurders en entrepreneurs, asook jeugontwikkeling. Hy het al verskeie kursusse en lesings oor hierdie en soortgelyke onderwerpe aangebied.

Nadat hy sy loopbaan by St. Luke in Albertinia begin het, het hy diens gedoen in Plettenbergbaai en is daarna aangestel as leraar in onderskeidelik Riversdal, Albertinia en daarna George. Hy was ook vir 'n tyd verbonde aan die Katedraal van St. George in Kaapstad. Sedert 2021 is hy verbonde aan St. Augustine Anglikaanse kerk in Melkhoutfontein.

Father Keith Muller is rector at St Augustine's Anglican Church in Melkhoutfontein where he has been active since 2021.

He studied theology at St Paul's College in Grahamstown, acquiring numerous other diplomas and qualifications since then in diverse subjects.

His special interests are development of rural communities, poverty alleviation, training and education of workers, managers and entrepreneurs as well as youth development. On these and related topics he has presented several courses and papers.

Having started his career at St Luke's in Albertinia, he subsequently moved on to Plettenberg Bay, becoming rector in Riversdale, and then Albertinia and George. He was also attached to the Cathedral of St George in Cape Town. Since 2021 to the present he has been at St Augustine's in Melkhoutfontein.

Rev Muller is active in community development and has served on several boards and councils.

10.2 Nóg U3A Stilbaai nóg die Komitee of enige lid sal aanspreeklik of verantwoordelik wees vir skade of verlies wat veroorsaak is deur enige aksie of handeling wat deur hom/haar of enige agent in diens van hom/haar of deur enige lid gedoen word, of nagelaat word, mits redelike toesig uitgeoefen is oor enige sodanige agent, of as gevolg van enige fout of weglating wat te goeder trou deur die Komitee of enige lid gemaak is, of as gevolg van enige ander saak of ding anders as opsetlike en individuele bedrog of wangedrag of onregmatige weglating aan die kant van die Komitee of enige lid wat gesoek word om aanspreeklik gehou te word.
