THE SINKING OF THE USS INDIANAPOLIS (Die praatjie is in Engels)

President Roosevelt se staatskip was ook die vlagskip van die Amerikaanse 5de Vloot tydens die Tweede Wêreldoorlog. Die skip is in Julie 1945 deur 'n Japanse duikboot gekelder, met enorme lewensverlies. Die skip se laaste en hoogs geheime sending was om komponente van die eerste atoombom wat in 'n aanval gebruik is, na 'n basis in die Stille Oseaan te vervoer.

Johan Viljoen het in Johannesburg grootgeword en het nadat hy gematrikuleer het, by die SA Vloot aangesluit. Hy was onder andere vir 28 jaar 'n intelligensie-offisier, en het ook as navigasie-offisier en as persoonlike adjudant van die hoof van die Weermag gedien. Hy was ook vir twee jaar SA se vlootattaché in Chili.

Nadat hy in 2003 die Vloot verlaat het, was hy in diens van 'n privaat sekuriteitsmaatskappy waar hy sekuriteitsinligting oor Afrikalande opgestel het. In 2016 het hy en sy vrou Erna van Pretoria na George verhuis.

THE SINKING OF THE USS INDIANAPOLIS (The talk is in English)

President Roosevelt's ship of state was also the flagship of the US 5th Fleet in World War II. The ship fell prey to a Japanese submarine in July 1945 with enormous loss of life. Her final top-secret mission was to carry parts of the first atomic bomb used in combat to a US airbase in the Pacific Ocean.

Johan Viljoen was raised in Johannesburg and joined the SA Navy after matriculating. He served in the Navy for 28 years, mostly as intelligence officer. His other appointments included serving as a navigating officer and as the personal adjutant to the Chief of the SA Defense Force. He also spent two years in Chile as naval attaché.

After leaving the Navy in 2003 he was employed by a private security company, where he compiled security reports on African countries. He and Erna moved to George from Pretoria in 2016.

10.2 Nóg U3A Stilbaai nóg die Komitee of enige lid sal aanspreeklik of verantwoordelik wees vir skade of verlies wat veroorsaak is deur enige aksie of handeling wat deur hom/haar of enige agent in diens van hom/haar of deur enige lid uitgevoer word, of nagelaat word, mits redelike toesig uitgeoefen is oor enige sodanige agent, of as gevolg van enige fout of weglating wat te goeder trou deur die Komitee of enige lid gemaak is, of as gevolg van enige ander saak of ding anders as opsetlike en individuele bedrog of wangedrag of onregmatige weglating aan die kant van die Komitee of enige lid wat moontlik aanspreeklik gehou kan word.
